

WHAT YOU NEED TO KNOW ABOUT OVERDRAFTS AND OVERDRAFT FEES

An overdraft occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. We can cover your overdrafts in two different ways:

1. We have standard overdraft practices that come with your account.
2. We also offer overdraft protection plans, such as a link to another account, which may be less costly than our standard overdraft practices. To learn more, ask us about this plan.

This notice explains our standard overdraft practices.

What are the standard overdraft practices that come with my account?

We do authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number
- Automatic bill payments

We will not authorize and pay overdrafts for the following types of transactions without your consent.

- ATM transactions
- Everyday debit card transactions

We pay overdrafts at our discretion, which means we do not guarantee that we will always authorize and pay any type of transaction.

If we do not authorize and pay an overdraft, your transaction will be declined.

What fees will I be charged if Security Bank and Trust Company pays my overdraft?

Under our standard overdraft practices:

- We may charge you a fee of up to \$32 each time an item is presented and represented for payment. Whether the item is returned or paid into overdraft.
- We will not charge you a fee if your account is overdrawn by \$10 or less on any given day
- If your account is overdrawn for 5 or more consecutive Business days, we will charge an additional \$5 for each of the consecutive Business days the account remains overdrawn beginning on the sixth business day.
- There is a limit of \$192 per day on the total fees we can charge you for overdrawing your account

What if I want Security Bank and Trust Company to authorize and pay overdrafts on my ATM and everyday debit card transactions?
